

## **DragonMindForge UG (haftungsbeschränkt) - data protection declaration from 27.09.2018**

On May 25th, 2018 the EU regulation 2016/679 "General Data Protection Regulation" (GDPR) came into force. In accordance with the GDPR, we inform you in this data protection declaration about all data protection aspects of our service offer.



We collect, process and use your personal data only in accordance with the following data protection declaration. Personal data in this sense are all individual details about personal or factual circumstances of a specific or identifiable natural person, such as your name, your telephone number, your address and other information that you provide to us about the use of our offers by you or when you contact us ("Personal data").

As a responsible company, we do not use automatic decision-making or profiling.

### **I. Responsible for data processing**

### **II. Collection and storage of personal data, as well as the type and purpose of their use**

#### **1. Type of personal data collected and stored**

In order to communicate and contact you, we may save the following personal data:

- Name and first name
- Gender (through salutation)
- Home / postal address
- Landline / cellular / fax number
- E-mail address

#### **2. Processing of personal data**

In order to be able to offer you our service, it is necessary to collect, save and process the data mentioned under point 1. This is done in accordance with Art. 6 Paragraph 1 GDPR for the following purposes:

- Contacting and communicating with you
- for sending consignments of goods or gift links

### **III. Retention / storage of your personal data**

Your personal data is stored in our in-house IT system that is protected from unauthorized access by third parties by firewalls and passwords.

The retention periods for data are based on commercial and tax regulations.

### **IV. Passing on your personal data to third parties**

Your personal data will only be passed on within the framework of tax and commercial law. Beyond that, no data will be passed on to third parties.

### **V. Your Rights**

#### **1. Right to information**

In accordance with Art. 15 GDPR, you are entitled to information about the personal data we have stored about you at any time. In particular, you can obtain information about the processing purposes, the categories of the data stored about you, the categories of recipients of this data, the planned storage period, the existence of a right to correction, deletion, restriction of processing or objection, the existence of a right of appeal to a supervisory authority, The origin of your data, if they were not collected from you, as well as, if necessary, meaningful information on their details.

Furthermore, according to Art. 20 GDPR, you have the right to receive your personal data that you have provided to us in a structured, common and machine-readable format or to request the transfer to another person responsible.

#### **2. Right to data erasure**

In addition, according to Art. 17 GDPR, you can request the deletion of personal data, unless the processing / storage is necessary to fulfill a legal obligation, for reasons of public interest or to assert, exercise or defend legal claims.

#### **3. Right to block / restriction of processing**

Furthermore, you have the right, in accordance with Art. 18 GDPR, to block or restrict the processing of your personal data if you dispute the accuracy of the data, the processing is unlawful, but you refuse to delete it and we no longer need the data, However, you need them to assert, exercise or defend legal claims or you have objected to processing in accordance with Art. 21 GDPR.

## **VI. Evaluation of personal data**

In addition to the aspects described in points I to III, we use parts of your data for internal evaluations in order to optimize our working methods, advertising measures and our service. In the reports created in this way, the data used can no longer be assigned to you.
